- In 2017, 34 employees were killed on the job.
 - o 12 Falls
 - 12 Struck-By
- FYTD 15 workplace fatalities have been investigated
 - 8 were Struck-by
 - 5 vehicles
 - o 1 brick
 - 2 moving equipment

- 1 Engulfment by soybeans
- o 1 Burn from fire
- o 2 Falls
- 2 OHV/Electrocution

Crystalline Silica Construction

- Occupational Exposure to Respirable Crystalline Silica, 1926.1153
- VOSH Effective Date
 June 23, 2017
- established a new 8 hr TWA PEL of 50 μg/m3
- required performing exposure assessments
- using exposure control methods
- using respiratory protection
- offering medical surveillance
- developing hazard communication information
- keeping silica-related records.
- 14 violations
- \$13,165

Recordkeeping

- Electronic OSHA 300A Submission
- VOSH Regulation 1904.41
- Effective Date in Virginia: February 15, 2018
- Submit 2017 Form 300A data to OSHA/VOSH via the federal OSHA webpage
- Submit by July 1, 2018
- Covered establishments with 250+ employees are required to provide their 2017 Form 300A summary data

Exempt

- peak employment during the previous calendar year was 19 or fewer
- industry is on this list, regardless of the size of the establishment.
- peak employment between 20 and 249 employees AND the industry is not on this list

Inspection Statistics

 - 2435 violations
 - 1808 Serious
 - o 6 Willful
 - 56 Repeat
 - **o** \$4,177,976

Goodyear Fatality Inspections

- Danville, VA
- August 2015-April 2016
- 4 fatalities, 7 VOSH inspections
- February 2017 settlement agreement signed
 - \$1.75 million in penalties
 - \$1 million paid in penalties
 - \$0.75 million maintained and put towards VPP
 - 3-5 year process to become VPP certified

Misclassification

- misclassification of employees as independent contractors
- misclassified employees denied benefits such as workers comp, overtime, minimum wage etc.
- effective July 2015
- each contractor will be asked to provide its DPOR contractors license and proof of license for any subs
- VOSH will make referrals to DPOR for using unlicensed contractors
- VOSH citations will receive no size or good faith reductions to penalties
- 173 Referrals YTD

Safety Standown

- o May 7-11, 2018
- Employers and employees voluntarily stopped work
- Discuss falls and fall prevention
- CY 2016 384 out of 991 construction fatalities nationwide (39%)


